# Admissions for the Academic Session 2019-20

# ALL INDIA AYUSH POST GRADUATE ENTRANCE TEST (AIAPGET) 2018

Notification No. AIAPGET/2018/01

Date:12.04.2018

The All India AYUSH Post Graduate Entrance Test 2018 (AIAPGET 2018) is a Computer Based Test (CBT) conducted by All India Institute of Ayurveda (AIIA), New Delhi on behalf of Ministry of AYUSH, Government of India.

### For Admission to AYUSH (Ayurveda, Unani, Siddha & Homeopathy) MD/MS/ Post Graduate Diploma Courses – Session 2018-19

- 1. The examination shall be held at various test centers in about 20 cities on 24th June 2018 (Sunday). The examination shall comprise of 100 Multiple Choice Questions (MCQ) from the respective stream (BAMS/BUMS/BSMS/BHMS) curriculum duly prescribed by CCIM/CCH.
- 2. AIAPGET 2018 is a single window entrance examination for admission to AYUSH MD/MS/Post Graduate Diploma courses for all AYUSH Colleges/ Institutions/ University/ Deemed University. No other entrance examination, either at state or institutional level shall be valid for admission to MD/MS/Post Graduate diploma courses in Ayurveda, Unani, Siddha and Homeopathy system of Medicine as per the directions of the Ministry of AYUSH, Govt. of India.
- 3. ATAPGET secretariat shall prepare a common merit list and will share it with the concerned authorities/States who will be responsible to prepare their own merit list considering the applicable rules, regulations, reservation policy and their other criteria, for the counselling. It will include All India quota (Open/ other State) seats & State quota seats for AYUSH MD/MS/ PG diploma courses for admission in all AYUSH colleges, Institutions & Universities/Deemed Universities.
- 4. AIIA & Ministry of AYUSH will not hold any counselling.
- 5. The entire procedure for registration and application for the examination is online.
